**PROJECT DESCRIPTION**

Awning Detailers, on behalf of property owners Robert and Joseph Luiz, James Munk, and Katherine Bean, is seeking an Administrative Design Review Permit to change the existing awning fabric color from blue to slate at 3001 Bridgeway (APN 063-161-04). The application includes revising existing sign copy on the awning valence to comply with an approved signage program for the property.

Staff will consider all materials submitted into the public record, including public comments, and decide whether to approve (with or without modifications) or deny the project.
