**PROJECT DESCRIPTION** Architect David Kessler, on behalf of property owner Dr. Corey Maas, is requesting a Design Review Permit, subject to Heightened Design Review, for a renovation and a 977 square foot addition to the existing 3,429 square foot, two story, single-family residence at 130 Currey Avenue. The project will include an expansion of the front entry, a new closet attached to the master bedroom, the creation of a new bedroom within the existing footprint of the structure, and the repair and reconfiguration of an entry deck.
