PROJECT DESCRIPTION

Sausalito Sister Cities Inc., requests approval of a Design Review Permit to allow a Capital Improvement Project to improve an existing public plaza located in front of Bank of America (750 Bridgeway) and south of the Downtown restrooms. The project is a Sausalito-Cascais (pronounced "Kush-kiesh") Sister City Calçadas (pronounced "cal-sadas") effort to enhance the existing plaza with artisanal stone paving arranged in a compass rose design, approximately 40-ft. in diameter.
