**STIPULATION AND ~~PROPOSED~~  
ORDER FOR LEAVE TO FILE FIRST  
AMENDED PETITION**

Action Filed: September 13, 2016  
CEQA Case

1 Petitioner and Plaintiff, the City of Sausalito (City), and Respondent and  
2 Defendant/Real Party in Interest, the Golden Gate Bridge, Highway and Transportation  
3 District (District) (collectively, the Parties), through their counsel, submit this Stipulation  
4 and Proposed Order for Leave to File First Amended Petition (Stipulation) with reference  
5 to the following facts:

6 WHEREAS, on September 13, 2016, the City filed a Verified Petition for Writ of  
7 Mandate and Complaint for Declaratory Relief, which included a cause of action alleging  
8 that the District violated California’s Environmental Quality Act (CEQA) in connection  
9 with its proposed Sausalito Ferry Terminal Improvements Project (Project);

10 WHEREAS, on May 26, 2017, the District authorized implementation of a modified  
11 Project and approved an Addendum to the Mitigated Negative Declaration for the Project;

12 WHEREAS, the City contends that the District’s actions in approving the modified  
13 Project and Addendum further violated CEQA, and therefore seeks to file an action or  
14 proceeding to set aside those actions within the meaning of Public Resources Code section  
15 21167;

16 WHEREAS, the Parties agree that it is appropriate for the City to file the First  
17 Amended Verified Petition for Writ of Mandate and Complaint for Declaratory Relief  
18 (“First Amended Petition”) submitted concurrently with the Stipulation and Proposed  
19 Order, which alleges an additional cause of action for violations of CEQA based on the  
20 District’s approval of the modified Project and Addendum.

21 Therefore, the Parties STIPULATE as follows:

22 1. The City shall be granted leave to file the First Amended Petition submitted  
23 concurrently with this Stipulation and Proposed Order.

24 2. The First Amended Petition shall be deemed filed and served as of the date  
25 this Stipulation and Proposed Order is lodged with the Court, thereby satisfying the  
26 requirements of Public Resources Code section 21167.

27 3. The District shall respond to the First Amended Petition within 30 days of  
28 the filing and service of this Stipulation and Proposed Order.
