

CITY OF SAUSALITO NOTICE OF PLANNING COMMISSION AND HISTORIC LANDMARKS BOARD PUBLIC HEARING FOR A DESIGN REVIEW PERMIT AND CONDITIONAL USE PERMIT AMENDMENT AT 30 EL PORTAL STREET – THE INN ABOVE TIDE

You are invited to attend a Planning Commission and Historic Landmarks Board public hearing on the following project.

PROJECT DESCRIPTION

Michael Rex Architects, on behalf of McDevitt Enterprises LP, requests approval of the following items concerning The Inn Above Tide hotel located at 30 El Portal Street within the Downtown Historic District (APN 065-133-19) (DR-CUP 17-346):

- Design Review Permit for exterior improvements including the removal of a chimney, modifications to windows, doors, railing, decking, and other associated improvements to support the interior remodel of guest suites on the south-east portion of the hotel; and
- Conditional Use Permit to amend Conditional Use Permit 95-92 for the conversion
 of an existing 1,987 square-foot residential apartment on the first-level at the
 southern end of the hotel into two new hotel suites, increasing the total number of
 hotel rooms from 31 to 33.
