Event Details

FEE \$75-\$125 based on type of vendor chosen

BOOTH Approximately 10'x10'; Vendor is responsible for all fixtures: tables, chairs, tents and tent weights. Tent pegs/staking are NOT ALLOWED and tents must be weighed down with tent weights – sandbags, water jugs, etc.

Set-up Times: 8:00am – 10:00am; Tear-Down: 3:00pm – 4:00pm

PARKING Temporary loading and unloading will be available along the road next to the tennis courts. Parking will be available in the Yacht harbor Parking lot free of charge. A parking pass will be provided on the day of the event.

INSURANCE & PERMITS & AGREEMENTS A **COI (certificate of insurance)** is required for all vendors.
For vendors selling merchandise they are required to obtain a **One-day City of Sausalito Business license**. This can be done online at Sausalito.HdIGov.com or by phone at 888-602-0239
All vendors must sign the **Vendor Participation Agreement**

Certificate of Insurance Requirement

(For each vendor)

Each vendor must submit the following:

- A copy of your **Certificate of Liability Insurance** (COI) with dates that will be current on May 1, 2019 and with the **Description of Operations** section stating exactly:
 - The City of Sausalito, its officers, employees, elected and appointed officials, representatives, volunteers and agents are added as Additional Insured excluding workers' compensation and Employer's Liability policy as required by written contract but limited to the operations of the Insured under said contract and always subject to the policy terms, conditions and exclusions.
- And the **Certificate Holder** section stating exactly:
 - City of Sausalito, 420 Litho Street, CA 94965
- And a signed copy of the **Vendor Participation Agreement**

CITY OF SAUSALITO VENDOR PARTICIPATION AGREEMENT

1. _____ (“Vendor”) has applied to participate in the City of Sausalito Wag dog festival event (the “Event”). In consideration of the City of Sausalito (the “City”) granting Vendor a permit to participate in the Event, Vendor agrees to all the terms and conditions set forth in this Vendor Participation Agreement (the “Agreement”) as follows:

2. Vendor shall defend with counsel acceptable to the City in its discretion, hold harmless, and indemnify the City, its elected and appointed officials, officers, employees, agents, assigns, volunteers, and representatives against any and all claims, damages, losses, and expenses of every kind arising out of, or connected in any way to, the Event, Vendor’s participation in the Event, and/or this Agreement, including, without limitation, claims for loss or damage to property, injury to or death of any person, attorneys’ fees, expert fees, and costs of suit.

3. Within thirty (30) days of notice from the City, Vendor agrees to pay the City for any and all costs incurred by the City to repair damage to City property directly or indirectly caused by Vendor and/or its officers, employees, volunteers, agents and/or any person who was or reasonably should have been under Vendor’s control, in connection with the Event.

4. Vendor agrees that by bringing any animal to the Event, Vendor is doing so at Vendor’s sole risk, cost, and expense, and any harm, risk, or damage sustained by any animal directly or indirectly arising out of the presence of Vendor’s animal(s) at the Event shall be Vendor’s sole and exclusive responsibility.

5. Vendor is responsible for cleaning up any messes made by any of Vendor’s animal(s) during the Event.

6. Vendor hereby represents and warrants that each and every one of Vendor’s animals is healthy, free of parasites, and has all core and noncore inoculations including, but not limited to, rabies, distemper, bordatella, and parvovirus.

- 7. Vendor hereby represents and warrants that Vendor’s animal(s) are not aggressive. Admittance of any animal to the Event is at the sole discretion of the City. If any of Vendor’s animal(s) engage in any behavior considered by the City to be of an aggressive nature, Vendor agrees to immediately remove the animal(s) from the Event, and Vendor agrees that it will not be entitled to any refund from the City.
- 8. Animals that have been cited under any California or local law as dangerous and/or vicious are prohibited from the Event.
- 9. This Agreement shall be signed by the Participant, or if the Participant is less than 18 years of age, by a parent or legally responsible guardian.
- 10. By signing this Agreement, I give my permission for my or my child’s image to be used to advertise the Event.
