**NOTICE TO ALL CONTRACTORS SUBMITTING BIDS FOR THIS WORK:**

You are hereby notified of the following information, changes, clarifications or modifications to the original Contract Documents, Project Manual, Drawings, and Specifications. This Addendum shall supersede the original Contract Documents wherein it contradicts the same and shall take precedence over anything to the contrary therein. All other conditions remain, UNCHANGED.

This Addendum is hereby made a part of the Contract Documents to the same extent as though it were originally included therein.

**RESPONSE TO QUESTIONS:**

**Question 1:** There is an existing pothole covered with a piece of plywood just west of the inlet behind the proposed sidewalk along MLK Park. Under the plywood, a shallow pipe was found during the site walk. Does the City have information regarding the owner of this conduit?

**Answer 1:** The conduit encountered is believed to be a PG&E electric utility line running parallel to the existing fence along the southern boundary of MLK Jr. Park. The total length of this line is currently unknown. The Contractor shall bear full responsibility for the positive identification and verification of this utility at all locations necessary to safely and properly perform the Work in accordance with the requirements of the Bid Documents. The Contractor shall protect and preserve this utility in place and shall take all necessary precautions to avoid damage during the performance of the Work.
